'Shake' line-up updated by Vodafone (Slide 4)

'REMIX' line-up updated by Vodafone effective as at May 2019

- Vodafone 'Remix Alpha' carries a lower monthly top-up fee of €15.00 instead of €20.00. Top-up fee for the 'Remix Beta' remains unchanged.
- 'Remix Alpha' now features a 10GB monthly data allowances up from 6GB. Meanwhile, the 'Remix Beta' which previously had no data bundle will now come with 4GB.
- The 'Remix Beta' will no longer come with €4.00 monthly credit on account, whilst the 'Remix Alpha' will come with €1.00 credit down from €6.00
- End-users can use their credit on account to purchase data bundle add-ons, make calls & send SMS once all units are consumed.

- GO launches new 'Turbo', 'Super' and 'Giga' home packs. Consumers that live in areas where fibre connectivity is not available may only opt for the 'Turbo' home pack.
- All plans include a fixed broadband connection and a land line. Consumers may also opt to add a mobile telephony plan and a pay-tv plan.
